### Important information

#### Maximum age 79 years

The insurance may only be taken out for people who have not yet reached their 80th birthday.

#### **Family insurance**

Family insurance applies to a maximum of 4 people (maximum 2 adults with their underage children). The sum insured applies per person.

#### Premium payment before travelling

The premium should generally be paid before travelling, but no later than the 5th day after entering Switzerland. After this, it is only possible to take out a policy with a health declaration, which you can download from www.erv.ch/h.

#### Legal information

The insurer is European Travel Insurance ERV, a subsidiary of Helvetia Swiss Insurance Company Ltd domiciled in Basel, Switzerland.

Maximum sums insured and premiums in Swiss francs. All premiums include federal stamp duty. As at July 2019. We reserve the right to make changes to benefits and premiums.

#### Confirmation for visa

If the insurance policy is not sufficient as confirmation for the relevant authority (consulate, etc.), you can request an additional insurance confirmation from us by calling 0900 275 075 (CHF 1.90/minute from a landline) or via info@erv. ch (send policy and premium payment receipt).

#### **Premium refunds**

Should the relevant authority reject the visa application, we will refund you the premium paid minus a processing fee of at least CHF 50. You can download the refund form from www.erv.ch/h.

#### Claim

Once treatment is complete, please send us all of the receipts for review. Our compensation payment goes directly to the policyholder and not to the doctor or hospital.

- Medical report or certificate (if available)
